A1: Disregard the requirement for 5 handheld programming devices.

Q2: Specification 28 31 76 (Fire Alarm/Mass Notification), section 3.7.2.1 states to provide 5 days of technical training for three government employees at the (fire alarm) manufacturing facility. Is this training going to be required?

A2: Yes

Q3: Who is responsible for providing, installing and commissioning the mass notification interface equipment (TRX401)?

A3: Per the revised drawings provided in amendment 1, the government is to provide, install and commission the TRX-401. FA contractor to commission FA system only.
